Application Connector (Intacct, CRM, Wherefour, Leaflink, Leaflogic, etc...):

The Application Connector is a bi-directional Interface. It can be used to send Data to the Data Hub creating a single source of truth.

Compliance Connector:

Used to send or update data to and from your Compliance Software and your other Business Software Applications.

Reporting Connector (Power BI, etc...):

The Report Connector provides read only access to data being stored in the Data Warehouse. Sample Reports can be used, or users can create their own reports.
